Liens have to be filed by an officer of the court vs HOA Board. Need to revise the form letter based on guidance from Mark Dietz. Don Anderson made a motion to meet with Mark before the end of the year. Wade Todd will schedule with Mark Dietz during the last week of November or first week of December. The plan is to send a letter with HOA dues notification by January 31, 2019 Don Anderson

We will adopt the budget at the next Board meeting. At the Annual HOA meeting we will discuss dues and let homeowners know that we might have to increase the amount in the future to cover costs of legal fees.
